

Welcome to Independence Aviation!

The following pages contain the documentation needed to get you set-up in our system and to meet the requirements for starting your flight activities. Please review the following documents and return to agreer@flywithia.com the completed forms:

1. Complete the Client Information Sheet and sign the Waiver of Liability & Hold Harmless Agreement.

For IA to participate (flight instruction, crewing, etc.), the Waiver of Liability & Hold Harmless Agreement MUST be signed and dated PRIOR to the operation of any aircraft, regardless of Ownership of Aircraft. This includes Privately Owned aircraft.

- 2. Sign the Policies & Procedures Acknowledgement form.
- 3. Sign the **Renter's Insurance Acknowledgement Form**, or provide your aircraft's Ownership Insurance Policy with IA as the "additional insured" if you are flying in your airplane.
- 4. Complete the Membership Sign-up form.
 - Member \$45.00 per month membership fee
 - Non-Member \$15.00 per Hobbs hour non-member fee
- 5. Provide a copy of your Passport only <u>OR</u> your Birth Certificate & Driver's License together.
- 6. Provide a method of **payment** (credit card).
- 7. If applicable, provide copies of your Airman Certificate, Medical, Last Flight Review, and date of last Instrument Proficiency Check.

Student Pilots

- Register with Cirrus Aircraft at <u>www.cirrusapproach.com</u> and purchase the appropriate learning kit. Your instructor can assist you with this step.
- Register with the FAA at IACRA for the "STUDENT PILOT CERTIFICATE" (instructor required for this step).
- Register with **MEDEXPRESS** 1st, 2nd, 3rd class medical.
- Become a member of **AOPA** and purchase **Renter's Insurance**.
- Purchase **"Foreflight"** from the Apple App store.
- Purchase the appropriate **Sporty's** ground-school and syllabus.
- Other items we suggest purchasing: headset(s), flight bag, iPad, NON-polarized sunglasses, logbook (or use a digital one).
